## BASIC INFORMATION AND RULES

### 1. UMPIRES WILL **NOT** BE PROVIDED. EACH SCHOOL IS REQUIRED TO PROVIDE THEIR OWN GRADED UMPIRE (AT LEAST A DISTRICT C GRADING)

2. ALL NSA RULES APPLY.
3. REGISTRATION WILL TAKE PLACE AT 07:30 ON THE SATURDAY MORNING AT THE COURTS.
4. EACH GAME CONSISTS OF 2 HALVES OF 10 MINUTES EACH, WITH A 2 MINUTE INTERVAL BETWEEN HALVES.
5. ALL GAMES WILL START ON TIME, TEAMS WILL BE PENALISED ACCORDINGLY IF THEY ARRIVE LATE.
6. THE TOURNAMENT WILL BE PLAYED ON A ROUND ROBIN BASIS, WITH POINTS BEING ALLOCATED AS FOLLOWS:
  - 3 POINTS FOR A WIN
  - 1 POINT FOR A DRAW
  - 0 POINTS FOR A LOSS
7. IN THE CASE OF TWO TEAMS FINISHING ON THE SAME NUMBER OF POINTS, GOAL AVERAGE WILL BE TAKEN, THEN THE TEAM SCORING THE MOST POINTS. IF THE TEAMS ARE STILL LEVEL, THE RESULT WILL BE DECIDED BY THE TOSS OF A COIN.

$$\text{GOAL AVERAGE} = \frac{\text{GOALS SCORED}}{\text{GOALS AGAINST}}$$

8. THE TOP 4 TEAMS IN EACH POOL IN ROUND-ROBIN SECTION WILL PLAY IN THE QUARTER-FINALS WHICH WILL BE ON A KNOCK-OUT BASIS. THE WINNERS OF THE QUARTER-FINALS THEN PROGRESS TO THEN PLAY IN THE SEMI-FINALS WHICH WILL ALSO BE ON A KNOCK-OUT BASIS.
9. THE WINNERS OF THE SEMI-FINALS THEN PROGRESS TO THEN PLAY IN THE FINAL.
10. IN THE FINAL MATCHES, IF THERE IS A TIE, AN EXTRA 3 MINUTES PER SIDE SHALL BE PLAYED, THEREAFTER, IF A TIE STILL PREVAILS, A TOSS-UP SHALL BE TAKEN TO DETERMINE THE NEXT CENTRE PASS. THE TEAM THEN SCORING WILL BE DEEMED THE WINNER.
11. MATCHES WORK ON RUNNING TIME; THEREFORE **NO INJURY** TIME WILL BE ALLOWED. INJURED PLAYERS MAY NOT TAKE PART IN THE REMAINDER OF THAT MATCH, AND SHOULD BE REPLACED AS SOON AS POSSIBLE ON COURT.
12. MATCH BALLS WILL BE PROVIDED.
13. MATCH BALLS SHALL REMAIN ON THE COURT, AND BE LEFT IN THE CENTRE CIRCLE AT THE END OF EACH ROUND.
14. SCORE CARD SHALL REMAIN AT THE TABLE. THE SCORER WILL TAKE THE GAME THAT FINISHED, SCORE CARD TO THE TECHNICAL TABLE.
15. TEAMS ARE REQUIRED TO BRING THEIR OWN SET OF BIBS MARKED WITH THE RELEVANT POSITIONS.
16. WE EXPECT ALL PLAYERS TO BE ON THEIR BEST BEHAVIOUR, AND TO BE AMBASSADORS OF THEIR SCHOOL.
17. YOU MAY ENTER A MAXIMUM OF 12 PLAYERS PER SQUAD.
