2. DEBIT ORDER

- Monthly payments may only be paid via debit order. The full year's tuition, development levy and PA Levy is split over 11 months and is payable from January to November.
- Debit orders are processed on the 25th and the last business day of each month.
- Interest is payable if fees are not paid upfront annually or termly. The interest rate is prime +2% .
- In the final term, the last debit order will be adjusted to cover outstanding incidentals and interest adjustments.

PLEASE NOTE

1. Interest is payable if fees are not paid upfront annually or termly. The interest rate payable is prime +2%.
2. Tuition Fees, Sundries, Sustainability Levy and PA Levy are charged and payable on the first day of each term.
3. Optional items excluded from Sundries are items such as school photos, hearing and eye tests, school magazines.
4. A full term's written notice, or fees in lieu thereof, is required to cancel ANY facility offered by the school.
5. Upon acceptance of a place, a non-refundable Development Levy and a Deposit is payable in order to secure a place. The Development Levy and Deposit collectively equate to one term's fee. The Deposit is refundable on departure provided a full term's notice has been received and fees are up to date. The Development Levy is not refundable.

- NB: If a term's written notice is not given then a full term's tuition fee will be charged in lieu of notice.**
6. Fees are increased annually on 1 January and the increase is communicated in November.
 7. A Foreign Student Levy of R600 per annum is applicable to all foreign students for administration.
 8. A separate Sibling Fees Schedule is available on request for 3rd and 4th siblings.
 9. A separate fee schedule is available for parents who wish to pay annual fees by credit card.
 10. It is essential that pupil accounts are up to date in order to participate in optional sports and cultural tours.
